Councillor Lynne Elson asked if any progress had been made in terms of contacting those organisations which had contributed to the initial funding pot for the patrol boat expenses. Cllr Scott reported that Exeter City Council had yet to appoint its Harbour Master or purchase a patrol boat and therefore it was possibly premature to offer the balance of the funds towards fuel costs, however he would speak to Stephanie Clark, the Officer for the Exe Estuary Management Partnership who had originally helped to set up the Exe Patrol Boat scheme to check on progress.
