F19/058 REPORT FROM THE RESPONSIBLE FINANCE OFFICER

The Responsible Financial Officer had previously circulated a Financial Report which included an Income and Expenditure Report, bank balances and a summary of funds which are held on behalf of the Council's charitable trusts. No queries were raised in respect of these reports.

The RFO reported that our IT Consultant undertook a complete review of phone packages when we moved back into the Town Hall and provided a competitive report which was taken to the Finance Committee for approval; a copy of the initial report will be circulated to Councillors.

Cllr C Nicholas checked the printed bank statements against the bank reconciliation on behalf of the Committee and confirmed they matched the funds reported.

F19/062 TO CONSIDER A REQUEST FROM THE TOWN CRIER, ROGER BOURGEIN TO INCREASE HIS HONORARIUM

After an in-depth discussion on the benefits the Town Crier brings to the Town, the Committee agreed to increase his honorarium to £1,000.00 per annum.

RESOLVED: that The Town Crier's Honorarium be increased to £1,000.00 per annum, subject to approval by Full Council.

F19/063 REVIEW OF AND APPROVE THE COUNCIL'S ANNUAL INVESTMENT STRATEGY.

The RFO reported that the Council were required by law to have an investment strategy. At the moment, the Council's Active Saver Account has a very high balance and only £85,000 is protected under the Financial Services Compensation Scheme. The Council already has £100,000 invested in a CCLA Public Sector Fund from which it can withdraw funds at short notice. There is an alternative property fund which could be invested in, but this is a riskier fund and is really aimed at a longer-term investments of 4 to 5 years. The RFO recommended that the Council deposits a further £220,000 from the Council's General Reserves fund and £123,000 from earmarked reserves (property sinking fund) into the CCLA Public Sector Fund. The Council's Annual Investment Strategy will then be updated to reflect the total amount held in the Public Sector Fund. The Committee gave authority for the RFO & Finance Officer to make the necessary deposits into the CCLA Public Sector Fund.

RESOLVED: that £220,000 be taken from General Reserves and £123,000 be taken from the Property Sinking Fund in Earmarked Reserves and be deposited in the CCLA Public Sector Fund.

F19/064 TO CONSIDER AND APPROVE FUNDING ARRANGEMENTS FOR THE 2019/20 COMMUNITIES TOGETHER FUND.

The RFO reported that it was agreed at Full Council along with the permission of the County & District Councils that we could hold onto the underspend from the 2018/19 Community Fund on the basis that we would

run the scheme again. In 2018/19 we received funding of £30k from the District and County Councils and we allocated just over £25k to projects. We receive an annual income of just under £5k a year from a unilateral agreement relating to the solar park scheme in Exmouth which has to be used for Community Projects from which we have committed £12k to Wild Exmouth but will still have £9,800 left. The RFO therefore recommended that this sum of £9800 be added to the underspend from 2018/19 to give a total funding pot of £14,300. After a discussion it was agreed to take a further £5,700 from reserves to add to the £14,300 and make a total funding pot of £20k.

RESOLVED: that the underspend of £4,800 from 2018/19, the Solar Park fund of £9,800 and £5,700 from reserves be added together, making a total of £20k for the 2019/20 Communities Together Fund.
