Declaration of pecuniary and personal interests

Cllr Lynne Elson declared a personal in respect of minute item 4 as she is a Trustee of Abbeyfield Exmouth Society Ltd.

To receive an update in relation to correspondence received from Thomas Westcott dated 13th March 2020.

The Town Clerk gave an update on the letter received from Tom Stuckey of Thomas Westcott that he had received from the Charity Commission in our quest to change the objects of the WA Westwood Trust. The Charity Commission did not feel that there was any reason to change the objects of the Trust whilst Rest Haven & Abbeyfields were still in existence, as it was possible for us to fulfil the charitable objects. He had suggested that we put an advert in the local paper and record annually that we have been proactive in advertising funds available. An advert was placed in October, no response was received. Cllr Fred Caygill, Trustee of Abbeyfield had put forward verbally to the Town Clerk an idea involving enhancements to an outside space which backs onto the allotments. The Town

Clerk asked him to cost the project and put an application in writing which she will bring to this working party for discussion and approval.

Tom also suggested that we be more proactive in our investment policy. Historically it has been difficult in managing a portfolio of shares that are in US dollars and listed on the US stock exchange. He has offered to put us in touch with a colleague who can investigate this for us, with a view to selling the US share holdings and give recommendations on what we can do to reinvest. In view of the Town Council Climate Change declaration, we need to give ethical consideration in terms of investment policy.

Cllr Lynne Elson proposed and Cllr Steve Gazzard seconded that Thomas Westcott be contacted and look at our options and give a report and investment strategy to discuss and consider at the next meeting. Also, that the Town Clerk write to Rest Haven to see if they require any funding for projects that they wish to carry out.

It is worth bearing in mind that if we do close the Trust, we will have to apply for Charity Status for CP Barrett as they are linked together with Exmouth Projects Trust under one registered charity.
