F21/031. To review Grant Applications for 2020/21

Cllr Olly Davey welcomed and invited Jenna Grace from Esteem Team CIC to give a presentation in support of her grant application. Jenna gave an in-depth presentation on the work they do and explained that the company was not a registered charity but a not-for-profit Community Interest Company in Exmouth who help children, young people and families who struggle with mental health or additional needs. Predominantly the work is with children & young people, and they have received a large amount of funding from Devon County Council to enable them to continue with this work in an educational context. The grant application they submitted was solely to fund a support worker to work with parent/carers of children with additional needs for which no funding is received and no charges are made to the parents/carers with the role completely reliant on grants. At the present time, 61 parent / carers of children with additional needs are being supported.

F21/035. To receive an update on the costs to date for the Beach wheelchair project and seek approval to use reserves to fund a wheelchair ramp.

The RFO reported that the even though we had stretched the funding received for the wheelchair project to cover as many costs as possible, it had not been taken into account that we would need an accessible ramp due to the unit entrance being slightly raised. The RFO was asking for authority to take money from reserves for the ramp and explained that the Council is in the process of getting quotes in line with Standing Orders but the quote received so far has come in at £5,500. The price might seem excessive but the proposed ramp extends the whole width of the building and is made of metal to meet safety requirements. Cllr Pauline Stott is trying to get other quotes. After a lengthy debate it was agreed to authorise up to £5,500 from reserves, dependant on getting 2 more quotations.
