As of 30th April 2023, a total amount of £2,075,398.33 is therefore held in bank accounts and investments under the name of Exmouth Town Council. This amount is broken down as follows: -

General Reserves: £229,166.00

Earmarked Reserves: £817,560.65

CIL: £656,541.52

Working Revenue: £372,130.16

The balances of the charitable trust funds and project funds held on behalf of others were also noted.
