A total of £800,000 remains invested in the CCLA Public Sector Deposit Fund.

As of 31st July 2023, a total amount of £2,179,968.97 is therefore held in bank accounts and investments under the name of Exmouth Town Council, broken down as follows:-

General Reserves: £229,166.00 Earmarked Reserves: £817,560.65 CIL: £973,999.78 Working Revenue: £159,242.54

The balances of the charitable trust funds and project funds held on behalf of others were also noted.

2023 and £97,684.26 was expended in July 2023. Councillor Olly Davey checked the bank statements against the bank reconciliation during the meeting.

F23/63. To discuss the scope to introduce a light touch grant application for small capital projects.

Seconded: Cllr C Nicholas

Councillor Mark Williamson explained that the context of this agenda item had been a request from Holy Trinity Church for funds to purchase a union flag. The Church had been put off by the seemingly overly onerous application process for a relatively small amount and Councillor Williamson wondered whether there was any scope to introduce a light touch application form for such requests.

The RFO reminded Members that the Town Council is not lawfully able to support the Church and that the application process and associated due diligence had been reviewed fairly recently by the Finance Committee. Processes and criteria had subsequently been updated in an effort to minimise risk to the Council.

Members debated the matter and agreed that the process needed to be flexible enough to encourage applications and also that the Town Council needed to promote the availability of funds. Councillor Steve Gazzard then proposed, seconded by Councillor Mark Williamson that the wording on the website should be updated to encourage potential applicants to have an informal discussion with the Town Clerk if in any doubt about eligibility or process.
